Subject: Letter of Support for Seniors Housing Information & Navigation Ease Program

This letter follows up on the August 30, 2024 meeting with you and the Westside Seniors Hub (WSH) on behalf of WSH's Community-Based Seniors' Services (CBSS) Partner Organizations. The meeting focused on senior tenants who are being negatively impacted by developments in the Vancouver housing market.

At that meeting you encouraged WSH to propose a housing navigation project to support the increasing numbers of long-term senior tenants who are first-time homeless or at risk of eviction. Many of these tenants are affected by the implementation of the Broadway Plan. As you will recall, we acknowledged the impact of housing precarity on seniors' health and its implications for the healthcare system.

Housing has been a key priority for WSH throughout 2024. Meetings of WSH Partners (listed on the top of page 2) and consultations with key stakeholders (tenants, BC Housing, Vancouver Coastal Health) identified challenges and potential solutions. WSH Council has explored other civic, provincial and federal programs that help urban seniors in precarious housing situations. Several WSH Partners are directly involved in supporting seniors housing navigation needs.

The <u>Seniors Housing Information & Navigation Ease (SHINE) Program</u> developed and managed by the Seniors Services Society of BC (SSSBC) is an example of a very effective housing navigation program. SHINE is a BC-wide program with documented success preventing homelessness and supporting over 6,000 seniors to be housed in the first half of this fiscal year alone. It has been recognized locally in the City of Vancouver's <u>Seniors Housing Strategy</u> (July 2024), provincially by the United Way's <u>Aging in Uncertainty: The Growing Housing Crisis for BC Seniors</u> (2023), and nationally by CMHC's <u>Future Cities Canada Spotlight: Housing Innovations</u> (2021). More than simply training staff and volunteers in housing navigation, the program also includes a monthly Community of Practice for updates and continuous learning, access to the SHINE Manager for consultation about complex cases, standard procedures for documenting and evaluating case management, and support for clients through to temporary and/or stable housing.

This letter, then, is a **full endorsement of the SHINE program with the strong recommendation that the BC government expand its financial support for the SHINE program in the 2025 budget to include ten (10) additional communities and multi-year funding**, as proposed by SSSBC in May 2024.
